

# **Cap and Trade Design Elements**

#### □ High-quality emissions data

- Define an emissions limit and establish a budget of "emission allowances"
- □ Limited use of high-quality offsets
- Track compliance instrument holdings and submission for compliance
- Open and fair auctions
- Effective market oversight
- Proposed link with Quebec
